



2024 PROGRAM GUIDELINES

OBJECTIVE

The SPARK Program (*Single Parent Award for Resilience and Knowledge*) recognizes the challenges and dreams of single parents who want to further their education and provide more opportunities for their families but are facing financial adversity.

The recipients join a strong, diverse, well-connected support network of Beedie Luminaries students and alumni, as well as community leaders and mentors.

NUMBER, VALUE AND DURATION OF SCHOLARSHIPS

In its 2024 program year, the Beedie Luminaries Foundation will offer Awards for the following:

FULL-TIME STUDENTS*

- Up to \$11,000 CAD per year for a college certificate/diploma or trades foundation programs, renewable for **up to two years of funding** OR
- Up to \$11,000 CAD per year for a bachelor's degree program, renewable for **up to four years of funding**.

Annual Payment Structure:

\$5,500 tuition payment - paid directly to the post-secondary institution in two equal payments (Fall and Winter Semester)

\$5,500 stipend - paid directly to the student in two equal payments (Fall and Winter Semester)

*Full-time studies are defined as completing at least 9 credits per academic term and **a** <u>minimum</u> of 24 percentage-graded credits (or equivalent) per academic year (3 terms) are required to remain eligible for scholarship renewal.

PART-TIME STUDENTS**

- Up to \$5,500 CAD per year for a college certificate/diploma or trades foundation programs, renewable for **up to three years of funding** OR
- Up to \$5,500 CAD per year for a bachelor's degree program, renewable for **up to six years of funding**.

Annual Payment Structure:

\$2,750 tuition payment - paid directly to the post-secondary institution in two equal payments (Fall and Winter Semester)

\$2,750 stipend - paid directly to the student in two equal payments (Fall and Winter Semester)

Part-time studies are defined as completing at least 3 credits per academic term and **a <u>minimum</u> of 12 percentage-graded credits (or equivalent) per academic year (3 terms) are required to remain eligible for scholarship renewal.

In addition to the financial support, the Beedie Luminaries Foundation offers student support, including:

- Invitations to Beedie Luminaries workshops & events;
- Invitation to join the Beedie Luminaries digital community;
- Student Success Advisor;
- BL Peer Support Groups;
- Access to mentors; and
- Career guidance.

ELIGIBILITY

An eligible 2024 applicant must be:

- a Canadian citizen or permanent resident since 2021;
- a full-time resident of British Columbia;
- at least 19 years of age;
- a single parent, with no spouse (regardless of marital status) or common-law partner present, living in a dwelling with one or more dependent children**,
- have applied or currently pursuing a <u>first</u> vocational diploma/certificate; or a <u>first</u> bachelor's degree in Canada as a full-time or part-time student at one of the eligible post-secondary institutions listed below;
- applying for this award for the first time (previous applicants are <u>not</u> eligible);
- able to begin studies in September 2024 or January 2025;
- ineligible for the BC Tuition Waiver Program (for former youth in care);

• <u>not</u> presently enrolled or concurrently receiving support from <u>WorkBC Single Parent</u> <u>Employment Initiative (SPEI)</u>.

SPARK cannot be held concurrently with the SPEI support.

****Dependent child:** An unmarried child, stepchild, adopted child or legal ward, supported by the applicant, who is:

- Under 18 years of age; or
- Under 21 years of age and registered in <u>full-time</u> school, university or vocational institute which provides a recognized diploma, certificate, or degree; or
- Of any age who, because of mental or physical infirmity, is accepted as a dependent for income tax purposes.

Please note, additional PTA (The Private Training Act) designated institutions *may* also be considered based on an individual's specific circumstances.

Recipients can attend on-line courses at one of the approved post-secondary schools.

FIELD OF STUDY / PROGRAM REQUIREMENTS

- There are no restrictions on the program of study or discipline.
- Program must be of a minimum of 1 year in duration.

CONDITIONS AND RESTRICTIONS

- Depending on the curriculum, an applied bachelor program may be considered either as a university-level program or a college-level program;
- Students must commence, or continue, their post-secondary studies in **September 2024** or **January 2025.** Deferrals in the first year are not permitted.
- Students must be enrolled in **full-time or part-time studies** at one of the eligible institutions listed in this document;
- The scholarship may be withdrawn if the family gross income exceeds the stated levels, if the student fails to make appropriate academic progress (according to the individual school and program's criteria), fails to obtain sufficient grades to pass a course or complete a program, withdraws from attendance at the selected institution, or commits an infraction or crime; (e.g., infraction such as breaching a school's code of conduct or engaging in plagiarism);
- Employees of Beedie and their dependents are not eligible to apply; and
- SPARK <u>cannot be held concurrently</u> with any other education-related financial award(s), that total more than \$10,000 per year, excluding student loans.
- Please note the Beedie Luminaries scholarship programs (Grade 12, SPARK and RISE) are limited to a maximum of 2 people in the same family (regardless of home address).

Please note: If you are currently on Income Assistance or receiving any government subsidies, please have a discussion with your Community Partner representative or a government social/case worker to make sure you have clearly thought out your decision and that you understand the impact the additional funding from the Beedie Luminaries Award may have on your existing benefits and subsidies. The Beedie Luminaries selection of scholarship recipients is made by experts from the community and educational institutions in British Columbia. The selection process will be conducted in three phases:

- **Phase 1:** Each application is read and scored by a minimum of two experts on the Beedie Luminaries Selection Committee.
- **Phase 2:** The Beedie Luminaries Selection Committee will invite shortlisted candidates for interviews.
- Phase 3: The Beedie Luminaries Foundation will meet to determine award recipients.

Once the selection process is complete, decisions are irrevocable. Only the finalists will be invited to an interview.

EVALUATION CRITERIA

- Demonstration of financial adversity;
- Personal circumstances;
- Applicant's proven work ethic, grit, and resilience in the face of adversity;
- Clarity of the applicant's educational goals, academic readiness, and focused commitment;
- Career goals;
- Quality and relevance of the reference letter.

All applicants will be notified of the results of the selection process, once available.

SUPPORTING DOCUMENT

Letters of Reference must be sent directly to Scholarship Partners Canada by the person you have selected to write the letter via email to <u>awards@univcan.ca</u>

The reference letter should not be from a family member or friend.

The email subject line should have the Applicant's First and Last Name.

LETTER OF REFERENCE

This letter should speak to the applicant's resilience, challenges, and educational goals.

The applicant would appreciate a prompt response in order to meet the application document deadline.
